- **Date and Time:** Saturday, August 14th from 12noon-6pm (outdoor even). **MASKS WILL BE REQUIRED.** Set up will happen on Saturday, August 14th from 10am-12noon
When you sign up for the CFF Vendors event you are committing to us that you will attend. If you are unable to attend, please contact us to let us know.
- **Pricing:** 10x10 space-\$30 (non-refundable) or a basket for the CFF basket raffle. You must bring your own tent, *table, chairs etc. You will be setting up in sand. This is an **outside** event. There will be no electricity available.
*Tables can be rented for \$5.00.
All spaces are a first come first served basis. Space is limit, and you are not considered a vendor until we receive your booth payment or basket. You will be assigned a space. Once a space is sold, it must be operated by the approved vendor. No Subletting. Space can be paid with check or cash. (checks postdated will not be acceptable and returned checks will be charged \$50 fee). The deadline to register for this market is July 15th 2021 or until spaces are full.

Vendor Refund Policy-NO REFUNDS will be given to the Vendor if vendor cancels or does not attend the event. All vendor payments are final and non- refundable.
- **Insurance/Permits:** The vendor is solely responsible for damages or liabilities resulting from the private dealings with any helpers, customers and sale of unsafe or unsound goods. The Bedford Community Foundation, Heart of Hope nor Forest View Lanes will not be responsible for damages or personal injury resulting from the use of umbrellas, tables, tents and other devices used in conjunction with the vendor space. The Bedford Community Foundation, Heart of Hope nor the Forest View Lanes have any responsibility that day to ensure the safety of vendors property, goods and consumables from damage, theft, fire, malicious mischief, accident, weather related incidents, or other. Vendor agrees to not hold the Bedford Community Foundation, Heart of Hope, Forest View Lanes or anyone helping with this event liable for any theft or damage caused to their inventory or personal effects during and/or after the Market. The Vendor is charged with the responsibility of protecting their own property at all times during the event and obtaining the appropriate liability and property insurance. The Vendor hereby agrees to indemnify, hold harmless, release, waive and forever discharge the Bedford Community Foundation, Heart of Hope, Forest View Lanes, volunteers, agents and owner of commercial property for all bodily and personal injuries resulting in death, and property damage, claims, actions, damages, liabilities and expenses, including reasonable attorney fees and court costs, which may occur as a result of the Vendor participation in the **August 14th CFF Vendors for the CFF Event . Masks are required!**
We are not permitting food vendors to sell food or drink due to Forest View selling food and drink for this event.
